1. Consider the following information:

Source 1 A newspaper extract dated 24 August, 2009 about a protest action made by Green Sense, an environmental concern group, against a fast food chain.



Green Sense members hold an event at a fast food shop to highlight the amount of waste the chain creates.

Based on estimates from a survey, Green Sense claims that the 210 outlets of a fast food chain in Hong Kong has dumped more than 400 million disposable items such as cups, paper boxes and styrofoam bowls in the past three years. Yesterday, the group threw a “party” to illustrate how much waste the chain generates. More than 150 packaging items and pieces of disposable cutlery were used during the event, which was attended by 10 guests.

The spokeswoman for the chain said they had continuously come up with viable green campaigns such as No Straw Day, but its priority was to provide convenience to customers.

- Citizen A: Fast food chains should come up with a 5-year plan to voluntarily cut their use of disposable items by 50%.
- Citizen B: The government should impose a levy of HK 50 cents on disposable cups and cutlery through legislation.
- Citizen C: We should boycott chains which have poor environmental practices.


2. Consider the following information:

Source 1

GLOBESITY – the origin of the word

This is a blend of *global* and *obesity*. A writer at the World Health Organization (WHO) used it for the first time in a report in February 2001 on the increasing risk caused by obesity worldwide, which is classified by many health professionals as a much more serious problem than smoking. Obesity is one of today's most visible public health problems, paradoxically coexisting with malnutrition, another major health problem. Overweight and obesity has become an escalating global epidemic. The fat epidemic — mainly the result of poor diet— is often thought to be peculiarly a US problem or more generally one of the more developed world, but it is a problem increasingly shared by less developed countries.

Source 1: Views expressed by three students towards the 'Trial Scheme on School Drug Testing'

Mary	I support the drug testing scheme, and believe it can act as a deterrent. It can discourage drug use and stop its spread within a school.
Marley	I am not sure to whom my drug test result would be disclosed and I am also worried about being punished for testing positive.

Commissioner for Narcotics, Ms Sally Wong said, "During the second half of 2009, the Narcotics Division, Security Bureau and Education Bureau held a series of consultation and sharing sessions to exchange views with the relevant stakeholders on the drug testing scheme* details. We have refined the details of the scheme after fully considering the views of relevant parties."

Under-Secretary for Education, Mr Kenneth Chen said, "Full protection of students' privacy is in place in the refined scheme details. Any drug testing results will be safeguarded under the principle of confidentiality and the relevant authorities will only provide the information to people on a need-to-know basis and will not let just anybody obtain such information."
